


Message from the founding directors







The Helios Global Group - who we are and what we do

We have designed a framework that aims to address the most critical sustainability issues facing our planet, and supports eight of the United Nations (UN) Sustainable Development Goals.¹











Silver medal for sustainability

In November 2023 we were awarded the EcoVadis Silver Medal for Sustainability, meaning we're ranked within the top 25% of >85,000 companies assessed globally.

The EcoVadis rating is based on an evidence-led assessment of our sustainability performance on four key themes - Environment, Labour & Human Rights, Ethics and Sustainable Procurement.

Our Silver Medal marks an important milestone in our sustainability journey, and we're looking forward to furthering our future efforts in this area.



Measuring and reducing greenhouse gas emissions

We have measured and submitted our key emissions data via the Carbon Disclosure Project (CDP), and we have publicly committed to reducing our Scope 1 and Scope 2 greenhouse gas emissions by 42% by 2030, at the latest. We're also committed to measuring and reducing our Scope 3 emissions.

These targets have been approved by the <u>Science Based Targets</u> <u>Initiative</u>, a global body enabling businesses to set ambitious emissions reduction targets in line with the latest climate science. It is focused on accelerating companies across the world to halve emissions before 2030 and achieve net-zero emissions before 2050.




